In consideration of being allowed to participate in the camp mentioned above, I/we acknowledge and agree that:

1. The risk of injury from the activities involved in this program is significant, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury, including paralysis and death, does exist.
2. I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the Releasees (as defined below) or others, and assume full responsibility for my participation.
3. I willingly agree to comply with the stated and customary terms and conditions for participation, including all policies of Lewis & Clark College. If however I observe any unusual significant hazard during my presence or participation or have concerns about my readiness or ability to participate (or, as the parent or guardian of a minor child, if I have any such concerns regarding my child), I will remove myself or my child from participation and bring these concerns to the attention of the nearest official immediately.
4. I have made Lewis & Clark College aware of any and all medical issues and/or conditions that they should be aware of regarding my participation in this athletic camp, as follows:

If I (or, as the parent or guardian of a minor child, if my child) suffers an injury or illness or otherwise requires medical attention, employees of Lewis & Clark College are authorized to assure or provide transportation to a medical facility. I/we authorize such emergency medical treatment as may be necessary and take full responsibility for any and all associated costs.

I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release, indemnify, and hold harmless Lewis & Clark College and its officers, trustees, officials, agents and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises used to conduct the event ("Releasees") with respect to any and all injury, disability, death, or loss or damage to person or property, whether arising from the negligence of the Releasees or otherwise, to the fullest extent permitted by law, arising from or related to participation in the camp mentioned above.
7. The laws of the state of Oregon govern this Agreement, without giving effect to its conflict of laws principles. All suits or claims relating to this Agreement, or to participation in this camp, shall be in the courts of the State of Oregon.
